

Sub: Saurashtra University, University Road, Rajkot - Recognition of MD(Microbiology) qualification increased against intake 3 to 4 seats in respect of students being trained at Pandit Deendayal Upadhayay Medical College, Rajkot.

Sir/ Madam,

I am to state that the General Body of this council at its meeting held on 26-27/03/2015 considered the Council assessor report (05.05.2014) on the standard of examination and other teaching facilities available at Pandit Deendayal Upadhayay Medical College, Rajkot for purpose of Recognition of MD(Microbiology) qualification increased against intake 3 to 4 seats granted by Saurashtra University, University Road, Rajkot.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the assessment report (05.05.2014) and decided to recommend that MD(Microbiology) qualification increased against intake 3(Three) to 4(Four) seats granted by Saurashtra University, University Road, Rajkot in respect of students being trained at Pandit Deendayal Upadhayay Medical College, Rajkot be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of notification upon which the institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the postgraduate course."
